## Privacy Notice

Your contact information, and any other information you provide on your membership form, will be kept on file by the BCSBA Committee in order to manage your membership, and to keep you informed about BCSBA matters. Communication will be mainly by email, but sometimes by post (e.g. to post your newsletter), and occasionally by telephone, should we need to speak to you.

Any financial information you have supplied will only be used by our Treasurer to process your membership application or renewal, or to deal with any other payments or refunds connected with your membership. It will not be shared with other committee members.

Although your membership will be renewed annually on 1st January, our constitution allows late renewal up until 1st May. Therefore if you fail to renew on 1st January, we will retain your data until 1st May the same year, unless you ask us to remove it. This is to enable the continuity of your membership, and so that we are able to send you reminders. If you do not renew your membership of the BCSBA by 1st May in any year, all the information we have on file or database about you will be deleted, in accordance with the new Data Protection (GDPR) rules.

If you wish to be included in the BCSBA Directory (published each year), we will also ask you for information about the sheep breeds you keep, your craft interests, services you can provide (e.g. spinning lessons), items you might have for sale (e.g. fleece), and information about your sheep or craft business. This information is voluntary, and only collected for the Directory. This Directory will be posted to all members once a year, some copies will be offered for sale on our stands at shows, and a PDF copy will be available for anyone (including the general public) to download from our web-site. Your information will only be included in the Directory if you give specific consent for this.

You can ask to see what information we hold about you, and request that we delete any or all of it, at any time.
